Greater Control and Insights Create a Foundation for Streamlined, Cost-Efficient Operations with invoice and expense automation

Prior to the implementation of Concur Expense and Concur Invoice, Sysmex Asia Pacific (Sysmex) was reliant on largely manual expense and invoice management processes. The overall Accounts Payable (AP) and Expense process was time-consuming and inefficient as the finance team had to manually go through stacks of invoices, follow up on supporting documents, ensure that expenses were charged correctly and track missing receipts.

It was a challenge to ensure that the claims and expenditures of 560 employees were in compliance with company policies and respective POs and PRs were raised and approved.

Multiple users could not charge their expenses to one project due to the restriction and constraint of approval metrics, which often resulted in frequent reclassification of expenses. Such manual systems led to increased maintenance costs, slower processing times and sometimes even delayed payments.

With business expansions in the recent years, such tedious manual processes eventually resulted in challenging record-keeping, difficulty ensuring compliance and honouring vendor and contract negotiations with proper approvals, as well as ensuring appropriate taxes are applied according to tax authorities.

With transactions being managed by multiple systems across different countries, this also meant that management had little visibility and control over employee expenses and invoice payments, which made it difficult to enforce compliant behaviours and to report accurate spending. In order to support a variety of manual operations, extensive IT maintenance support is often required for existing systems, which resulted in a relatively longer downtime.

IMPROVING THE EMPLOYEE EXPERIENCE

"Right from the beginning, SAP® Concur has standardised and simplified our processes, which meant the team spent less time providing enduser support, processing expenses and more time on value-adding activities" says Nelson Lee, Chief Financial Officer, Sysmex Asia Pacific Pte Ltd.

The user-friendly and intuitive platform meant that user training was very straightforward. Once SAP Concur was integrated into the company's single sign on (SSO) system, the log-in process was seamless, especially via the mobile phone application. Concur Invoice made it easy and accessible for employees to manage non-travel related expenses. Employees could receive approval, access the authorisation matrix and read up on policy compliance, in one single platform.

The reduction of time spent on manual collation and scanning of receipts and Supplier Invoices with Concur led to greater productivity as Sysmex employees were able to reclaim and reallocate their time towards higher value-adding activities.

The mobile app that comes with Concur Invoice and Concur Expense has been especially useful in supporting Sysmex Asia Pacific's move to a hybrid working environment. This allows employees to submit, review and approve expenses and invoices on-the-go.

IMPROVING SPEND VISIBILITY AND REPORTING

With a single, easy-to-use platform, Concur Invoice and Concur Expense enabled the Sysmex finance team to have a holistic grasp over cost-control and spend management. The purchase requests allowed employees to put forth a purchase request for pre-approval with the Head of Department (HOD). In situations where the invoice amount exceeded the purchase order amount, internal controls would automatically reroute the request to the HOD for re-approval.

With the implementation of Concur Expense, there was greater visibility into T&E, more accurate and granular reporting has helped the Sysmex team improve data quality around compliance and resulted in significant time savings.

SAP Concur's multi-user platform software also allowed the Sysmex team to have a consistent process throughout the Asia-Pacific region and allowed them to efficiently validate their compliance against various approval, authorisation and purchasing policies.
