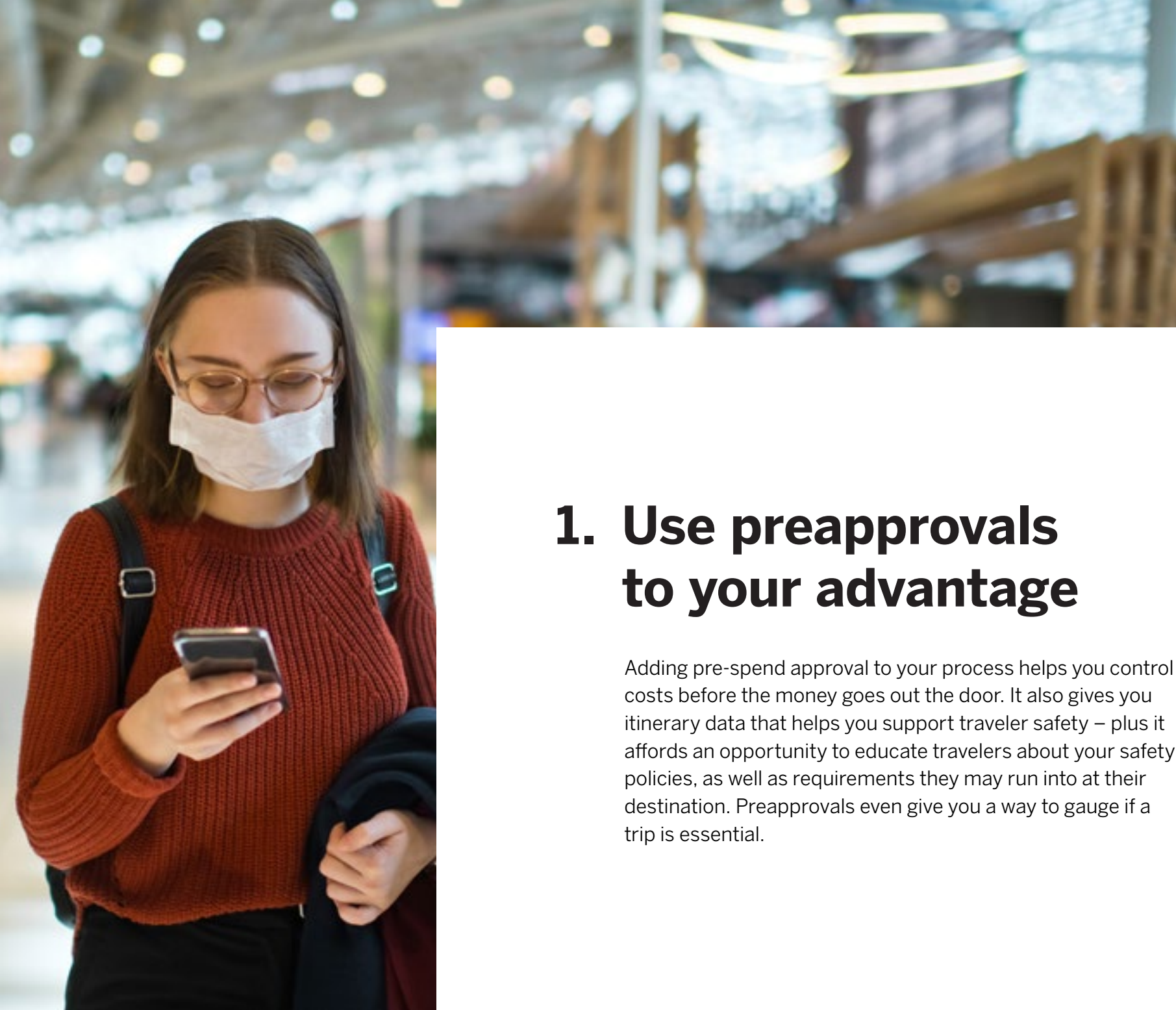
**6 ways travel managers

Here are six tips to take to heart





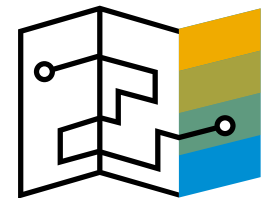
1. Use preapprovals to your advantage

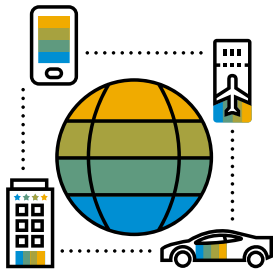
2. Capture direct bookings

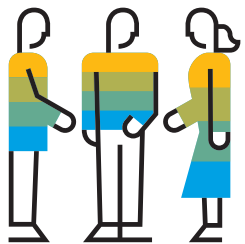
4. Make sure reporting can keep up

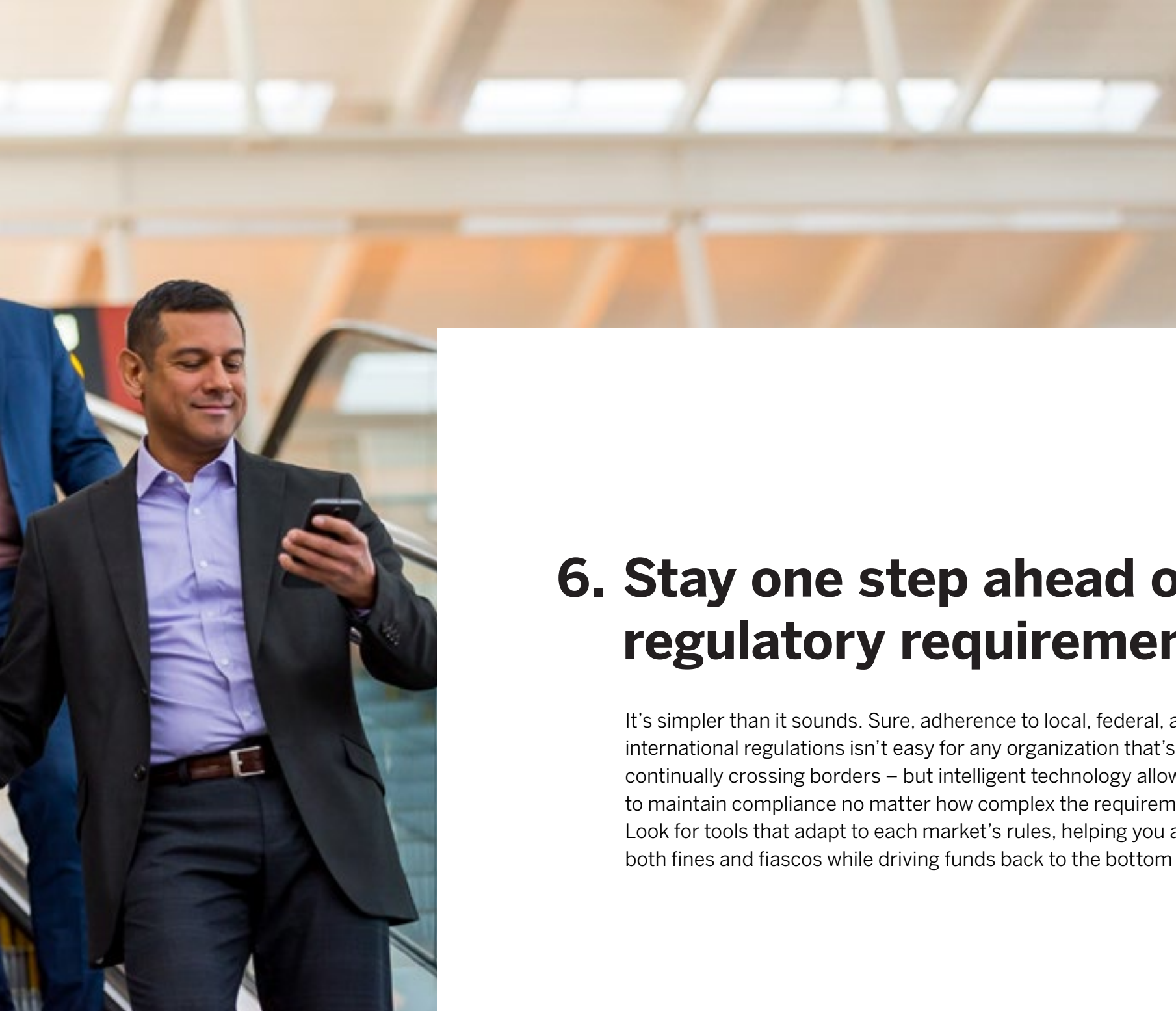
