Manual expense management wasn't meeting

the needs of a growing organization

With 1500 employees spread across the country, Panasonic India was looking forward to making its expense management process more efficient to boost its market competitiveness.

The company was managing its expense management processes manually. Most of the employees paid for travel and other expenses from their pocket and later filed claims to get reimbursements. As this process was manual and paper-led, the reimbursement cycles were long, and employees were unable to know the status of their claims due to the absence of a transparent approval tracking mechanism. Moreover, they couldn't submit claims while on the go.

The company's finance department had to spend a lot of time verifying and reconciling invoices. There was limited visibility into expenses so getting budgetary visualization for planning purposes wasn't possible. Additionally, ensuring and enforcing adherence to the spend policies was a major challenge for the finance department.

The HR department was concerned about the poor employee experience due to delays in the processing of the claims and disbursal of reimbursements.

In a nutshell, the manual process for T&E was resulting in productivity losses, affecting employee morale and making policy adherence and compliance difficult.

The entire process was paper-based. Employees had to raise manual travel requests, which was tedious and time-consuming. We were looking to automate the process and selected a cloud-based T&E solution provider to give us better operational agility.

Simplified expense management for improved visibility, compliance and employee experience

Panasonic India decided to implement SAP Concur solutions and integrated it with SAP ERP and SAP Success Factors solutions. While the integration with SAP Success Factors solutions helped fetch the employee data, other spend related data were accessed through the SAP ERP system.

Starting in January 2018, the implementation was completed in May 2018. The functionalities were rolled out gradually, and employees were trained to ensure faster adoption and usage.

The solution helped the company accelerate the claim approval process and shorten the reimbursement cycles. Employees can now submit claims quickly while on the go and track their claim status in near real-time. Even in the case of changes in management or approvers, the claim approval process remains unhindered, ensuring a smooth experience for the employees. The reimbursement cycles were shortened by 50% on average (from 14–30 days to 7-10 days).

A 30% improvement in operational efficiency has been a significant outcome of the solution. The finance department can now better maintain invoice repository as they have access to a system designed to support business rules, making policy adherence possible. The policy compliance is now more streamlined, and the audit process has also been simplified dramatically as the finance department can easily maintain audit trails.

The implementation of SAP Concur solution has made life a lot simpler for employees. They can now submit claims from home or while on business trips and check out the status of their claims as and when they want. As there is complete policy visibility, they know exactly what kind and category of expenses can be claimed and which are not allowed. They can now plan their travel in advance and get the bookings done in time as per the guidance of the pre-approved policies. In other words, employees have become more disciplined when it comes to making business expenses.
