How Automating Spend Management Helps States, Cities, and Counties Increase Compliance and Reduce Risk

As spending becomes increasingly decentralized and employees are empowered to make more and more spending decisions on their own, the risk of fraud goes up in both public and private sector organizations. However, the stakes are even greater in the public sector. Since these organizations are funded by public/tax dollars, transparency and accountability are paramount. Public disclosures of fraud, waste, and abuse can have severe reputational and financial consequences for states, cities, and counties.

A recent Kelton Global study surveyed 162 financial decision makers working in state, city, and local government and found that despite their best efforts, government organizations are struggling to be compliant. Additionally, these organizations are tasked to minimize mistakes and fraud, which are in large part due to error-prone, disconnected systems, outdated technology, and manual processes. Many financial decision makers who have integrated fully automated solutions have shown that their organizations are more efficient in managing budgets, better at remaining compliant, and protecting themselves from errors.

Government Organizations are Struggling to Remain Compliant

Nearly all (90%) financial decision makers working in state, city, and local government say their organization is doing all it can to remain compliant. Many have institutionalized critical solutions such as internal and external audits, working with a compliance office, and even encouraging employees to gather information at industry events in an effort to keep their organization up-to-date on data and regulatory compliance. Despite doing all they can, maintaining compliance is not without its challenges.

Additionally, many government organizations use manual or legacy systems to manage organizational spend. In fact, nearly **3-in-4** decision makers admit regularly maintaining compliance within their organization is a struggle. Obstacles such as employees accidentally filing the same expense report multiple times (**30%**), filing potentially fraudulent expense reports (**27%**), or unintentionally reporting incorrect budget data based on inaccuracies within financial systems (**28%**) are just a few of the many internal issues that threaten a government organization's ability to remain compliant at all times.

These challenges are perpetuated by the financial tools and systems that government organizations use—many of which are manual or legacy systems that are subject to frequent errors.

Manual Systems Can Lead to Reputational Risk

A key challenge in maintaining compliance is the frequency of errors in expense reports and invoices. About **1-in-3** decision makers say that errors almost always occur across expense reports and invoices—a trend that many admit has increased over the last 12 months. At the heart of these issues are the legacy or manual systems used to manage expenses. Two thirds of decision makers acknowledge that their current manual systems are prone to mistakes and may be costing the organization time and money—all of which could damage their organization’s reputation with the public they are serving.

And these are not isolated issues impacting only a select few organizations. According to our survey, problems with accuracy are pervasive and only growing. Fraud, waste, and abuse are challenges nearly **3-in-4** decision makers face today, and **63%** say their organization has not improved efficiency in spending taxpayers’ dollars over the past year. Additionally, **3-in-10** report their organization’s vulnerability to the risk of fraud and abuse has increased in the past 12 months.

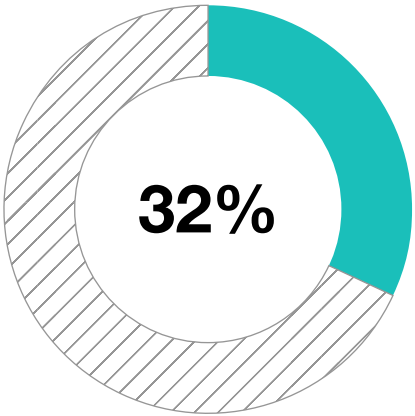
To address these growing challenges, financial decision makers must consider implementing automated, integrated financial systems within their organizations.

Automation Increases Efficiency, Supports Compliance, and Reduces Risk

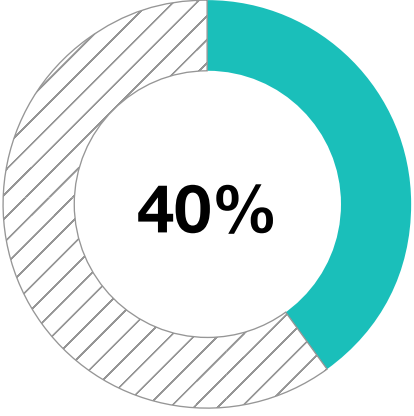
Spending extra time processing expense reports and invoices hinders organizational efficiency and prohibits employees from focusing on citizen services. A solution: moving to integrated and automated financial systems. Those using manual or legacy systems are spending over **5 additional hours** processing each expense report and over **2 additional hours** processing each invoice than their peers who are using fully automated systems. Given the sheer volume of reports and invoices processed each month—472 and 300 respectively—it quickly adds up to thousands of hours that could be better spent on more mission-critical tasks.

Nearly all (**95%**) government decision makers who have adopted an automated system for travel, expense, and invoice management say their organization has benefited from making the switch. Notable improvements include reducing actual instances of fraud, waste, and abuse of taxpayers’ dollars that would put organizational reputation at risk, as well as increasing efficiency in managing their budget. Furthermore, decision makers who don’t currently centralize travel, expense, and invoice management through one integrated solution are **25%** more likely to say their organization struggles staying up-to-date on regulatory compliance.

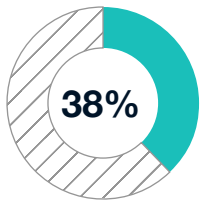

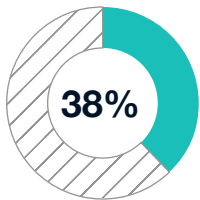

Currently, less than **2-in-5** decision makers say these two departments work extremely closely within their organizations. Despite a common disconnect, nearly all **(99%)** believe greater cohesion between Finance and IT can benefit their organization. Notable perceived benefits include improving their organization’s ability to remain compliant **(49%)** or be able to spot instances of fraud, waste, and abuse more easily **(41%)**.
