





### **Build the right foundation.**

Set your organization up for success by establishing the right policies, training and T&E best practices from the beginning.




#### Start with smart policies.


#### Train your employees on proper T&E practices.

Not all employees will read through pages and pages of written policy documents on their own. Develop an engaging training program to teach them about anti-corruption and T&E best practices for your company.




#### Help travelers make the right decisions.


#### Make it all mobile.


## Maintain visibility.
